

TERMS AND CONDITIONS FOR THE WESTFIELD SHOP YOURSELF RICH PROMOTION 2008

1. The promotion starts at 9am on Monday 26 May 2008 and concludes when each participating Westfield centre closes for trade on Sunday 17th August 2008 (Promotion Period). Entries received after this closing time will be ineligible for entry.
2. Each purchase receipt for a single purchase of \$50 or more made in a participating Westfield centre during the Promotion Period (from all retailers excluding supermarkets) is eligible for one entry into both the grand draw and one weekly draw provided it is submitted on a fully and correctly completed entry form. For the purpose of this promotion, purchases of Westfield gift vouchers are not eligible for entry into the draws.
3. Entry into both draws is also available online at www.whatswhat.co.nz. Each online entry for each participant will be allocated 2 entries into the prize draws.
4. Entries must be submitted either a) by completing and submitting the online entry form at www.whatswhat.co.nz or b) on a fully and correctly completed paper entry form (as provided by Westfield to retailers in the applicable participating Westfield centres) and left in the specially marked entry barrels at participating Westfield centres. One entry into the draws will apply for each paper entry form.
5. **Grand prize:** All entries received during the Promotion Period will be eligible for the grand prize draw. There will be one randomly drawn winner at Westfield New Zealand Limited, Level 2, Office Tower, 277 Broadway, Newmarket, Auckland on 15th September 2008. The winner of the grand prize will receive \$100,000. The winner will be notified by 16th September 2008 and must collect their prize by 23rd September 2008.
6. **Weekly prize:** All entries received during the Promotion Period will be eligible for one entry into the weekly prize draw for the week in which they are received. There will be 12 weekly prize draws. Each week begins at 9am on the Monday and concludes when each participating Westfield centre closes for trade on the Sunday of that week (Promotion Week).
 - i. There will be one randomly drawn entry at the end of each Promotion Week at each participating Westfield centre. There will also be one randomly drawn entry from online entries received during that Promotion Week. These thirteen entries will then be pooled and from this pool one random winner will be drawn at Westfield New Zealand Limited, Level 2, Office Tower, 277 Broadway, Newmarket, Auckland on Tuesday 3rd June 2008 and every seven days thereafter until and including Tuesday 19th August 2008. Each winner in a weekly prize draw will receive \$10,000 of Westfield gift vouchers.
 - ii. The Westfield gift vouchers must be used within 1 year of the date of their validation (validation date being the date the prize winners collected their gift vouchers from the participating Westfield Centre). The winners can use the Westfield gift vouchers in any participating Westfield Centre of their choice within New Zealand (see condition 9 below).

 - iv. Winners must claim their prize no later than by 5pm on the following dates: Week 1 by 11th June 2008, week 2 by 17th June 2008, week 3 by 24th June 2008, week 4 by 1st July

2008, week 5 by 8th July 2008, week 6 by 15th July 2008, week 7 by 22 July 2008, week 8 by 29th July 2008, week 9 by 5th August 2008, week 10 by 12th August 2008, week 11 by 19th August 2008, week 12 by 26th August 2008.

7. All winners must claim their prizes in person from the participating Westfield Centre where the entry form was submitted. For online entries, winners must claim their prize from the centre where their purchase receipt is from. To claim their prize each winner must supply the original purchase receipt (no credit card or duplicate receipts or bank statements will be accepted) and Government issued photo identification to verify their entitlement in order to claim the prize.
8. If the prize in any prize draw is not claimed by the times detailed above then Westfield reserves the right to redraw that prize and award it to a replacement winner. Each winner of a redraw will be contacted on the day of the redraw and the winner of a redraw will have 7 days from the redraw to claim their prize.
